Parking Changes Coming to Columbia City in Fall 2017

Over the past two years, the Seattle Department of Transportation (SDOT) has studied parking and access in Columbia City. We used your feedback to develop a Neighborhood Parking Plan.

Beginning in fall 2017, SDOT will make changes to area parking regulations to make parking more available and predictable for area residents, customers, visitors, and employees. See inside for details on planned changes.

What is the plan?

- Paid parking** will replace existing unpaid time limits. Paid parking will have a mix of 2- and 4-hour limits. 2-hour spaces allow 3 hours of parking to be purchased after 5 PM.
- Unpaid time limits** will be added to other commercial streets in the area that currently have no time restrictions.
- Restricted Parking Zone (RPZ) 29** is planned to expand east. All residents and employees in the expanded RPZ area will be eligible for permits. There will be a Public Hearing on the RPZ expansion on July 10, 2017 from 6:00 PM to 7:30 PM at Rainier Arts Auditorium at 3515 S Alaska Street. Please see project website below or contact us for more information.
- New RPZ 29 spaces** will be added on S Ferdinand St.
- Parking restrictions** will be posted on streets east of 39th Ave S to improve vehicle circulation.
- Designated disabled spaces** with a 4-hour time limit will be added on S Edmunds St and S Hudson St.
- Evening passenger load zone** will be added on the east side of Rainier Ave S between S Edmunds St and S Ferdinand St. There are existing load zones on the west side.

Why make these changes?

Through over a year of outreach and parking studies, we've heard and seen that available parking is increasingly difficult to find in parts of Columbia City, and that certain streets can be difficult to navigate. The elements of this plan work together to improve circulation and make parking more available and predictable for residents, customers, visitors, and employees. Implementing paid parking and time limits will improve turnover in the most congested areas of the neighborhood. The RPZ expansion will prevent long-term parking on residential streets in the neighborhood by those who don't work or live in the area. Small areas of parking restrictions will improve circulation on long residential blocks east of Rainier. An evening passenger load zone and new designated disabled spaces will also improve access in the neighborhood.



PLANNED CHANGES

- Paid, \$1/hr, 8 AM-8 PM Mon-Sat, 2 hr Limit, with 3 hours after 5 PM (60 spaces)**
- Paid, \$1/hr, 8 AM-8 PM Mon-Sat, 4 hr Limit (20 spaces)**
- RPZ, 7 AM-6 PM Mon-Fri, 2 hours except by permit (390 spaces)**
- Unpaid Time Limits, 7 AM-6 PM, Mon-Sat, 2 hr limit (40 spaces)**
- Sign No Parking**
- Establish Vehicle Turn-out Areas**
- Relocate Existing Daytime Load Zone and Add Passenger Load Only 6 PM - 2 AM**
- Add New RPZ 29 Parking Spaces**
- Designated Disabled Parking, 4 hr Limit**

When will these changes happen?

Implementation is planned for fall 2017. Schedule updates will be posted on the project website.
